Instructions for *Notice of Election* packet

WHO SHOULD READ THIS NOTICE

Those responsible for communicating information to employees.

ACTION REQUESTED

In order to inform your employees about the upcoming 2022 OPERS Board of Trustees election, please complete the following:

- Today, the standard election packets were mailed to employers. Included in the mailing is the attached poster. We ask you to display this poster in a prominent place (additional copies can be ordered from the *Employer Forms* page on www.opers.org or by contacting your dedicated account representative at 888-400-0965 or employeroutreach@opers.org). The attached poster can also be circulated to employees electronically if employers are operating in a remote working environment.
- Provide interested candidates with the opportunity to copy the following items, also included in the mailing:
 - *Candidate Guidelines 2022 Board of Trustees Election*
 - *OPERS and Ohio Deferred Compensation Boards of Trustees Job Description* (both sides)
 - *Board Member Fiduciary Obligations*
 - *Certification by Candidate for Election*
 - *Employee Representative Biographical Statement*
 - *Nominating Petition Instructions for Employee Candidates*
 - *Nominating Petition for an Employee Candidate to the OPERS Board of Trustees* (both sides)
 - *State Required Campaign Finance Forms packet* (both sides where applicable)

Employees qualifying as re-employed retirees are not eligible to run for an employee seat on the Board. However, re-employed retirees are eligible to run for the retiree Board seat up for election. If a re-employed retiree is interested in running for office, contact your dedicated account representative to obtain the above items specifically for re-employed retirees.

If you have branch offices, please inform the human resources departments that the above information is available on our website, including the election poster which can be printed or ordered from the *Employer Forms* page.
