#### **Investment Strategy**

This fund is intended for long-term investors seeking to capture the earnings and growth potential of large- and midsized U.S. companies.

This fund seeks to match the performance of the Russell 1000® Index, which captures the large- and mid-cap representation of the U.S. equity market. The Russell 1000® Index is approximately comprised of the 1000 largest companies within the Russell 3000® Index and represents approximately 90% of the total market capitalization of the Russell 3000® Index.

#### Category Description: Large Blend

Large-blend portfolios are fairly representative of the overall US stock market in size, growth rates and price. Stocks in the top 70% of the capitalization of the US equity market are defined as large cap. The blend style is assigned to portfolios where neither growth nor value characteristics predominate. These portfolios tend to invest across the spectrum of US industries, and owing to their broad exposure, the portfolios' returns are often similar to those of the S&P 500 Index.

### **Volatility Analysis**



In the past, this investment has shown a relatively moderate range of price fluctuations relative to other investments. This investment may experience larger or smaller price declines or price increases depending on market conditions.
