OPERS offers Connector Readiness seminars this spring



OPERS is not required to provide health care coverage to retirees or their dependents and will only do so at the discretion of the Board of Trustees.

Disability benefit recipients must complete and return an Employment and Earnings Statement

Every year OPERS disability benefit recipients, regardless of their age, are required by state law to complete an Employment and Earnings Statement. You will need to indicate whether or not you were employed in the previous year. If you were employed, you will need to provide the total of your earnings as well as information about the employer(s) for which you worked. If available, please provide a job description for each position you held.

It is important that you submit this statement. The information will be used to assist OPERS in the proper administration of its disability benefits program. To ensure continued receipt of your disability benefits payment, you must submit the Employment and Earnings Statement even if you did not work. These statements no longer require a notarized signature.

Failure to comply with this request will result in suspension of your monthly disability benefit.

OPERS will begin mailing statements during the last week in February. If we have not received a form back from you, we will send you a second notice on March 18, 2015. Employment and Earning Statements cannot be accepted by fax so it is important that you mail the completed form to OPERS as soon as possible.

You have until April 15, 2015 to complete and mail the form back to OPERS. If we do not receive your form by no later than April 15, your May disability benefit payment and subsequent disability benefit payments will be held until we receive the form.

Legislative update

New leadership in the Ohio legislatureIn January, the OPERS GovernmentRelations team welcomed backmembers of the Ohio Generalthe Senate side

members of the Ohio General Assembly and U.S. Congress as they began new legislative sessions in Columbus and Washington, D.C.

Ohio's congressional delegation remains the same after the November 2014 election; however, there are a number of new faces at the Statehouse.

In addition to 29 new state legislators, the Ohio House of Representatives ushered in new leadership. Representative Cliff Rosenberger (R-Clarksville) replaced term-limited Representative William Batchelder (R-Medina) as Speaker of the House. Representative Fred Strahorn (D-Dayton) replaced termlimited Representative Tracy Heard (D-Columbus) as minority leader. On the Senate side, Senate President Keith Faber (R-Celina) remains in his leadership position, as well as minority leader Senator Joe Schiavoni (D-Boardman).

The OPERS Government Relations team continues to educate legislative leaders on important issues of interest in 2015 and beyond, such as:

- The implications of new GASB standards for public pension systems' and public employers' accounting
- OPERS' continued opposition to proposals requiring mandatory Social Security coverage for our members

- Advocacy on health care issues, such as biosimilar pathways, lower exclusivity periods and ways to reduce the cost of prescription and specialty drugs
- The multiple ways OPERS is good for Ohio's economy, via benefit payments to retirees, ensuring they have income in retirement that keeps them from having to rely on other safety net programs like Medicaid or SNAP
- OPERS' continued support for retirement options for all Ohioians in the workforce, both in the public and private sector

2014 Form 1099R and Benefit Recipient Tax Guide available online

OPERS mailed Form 1099Rs for tax year 2014 in January. If you wish to print an additional copy of your 1099R, you can access it by signing in to your online account at www.opers.org. Once you are signed in, click on "Documents." If you need help printing your 1099R, OPERS offers a recorded presentation that provides step-by-step instructions. Click on "Educational Opportunities" under the retiree heading on the OPERS website home page.

Ohio PERS Board of Trustees

The 11-member OPERS Board of Trustees is responsible for the administration and management of OPERS. Seven of the 11 members are elected by the groups that they represent (i.e., college and university non-teaching employees, state, county, municipal, and miscellaneous employees, and retired members); the Director of the Department of Administrative Services for the state of Ohio is a statutory member, and three members are investment experts appointed by the Governor, the Treasurer of State, and jointly by the Speaker of the Ohio House of Representatives and the President of the Ohio Senate.
